REPLY COMMENTS OF CITIZEN POWER, INC.

**INTRODUCTION**

In the above-referenced docket, the Commission, on August 17, 2011, proposed several nonsubstantial rule changes to Chapters 4901:5-17, 4901:5-19, 4901:5-21, 4901:5-23, 4901:5-25, 4901:5-29, 4901:5-33, 4901:5-135, and 4901:5-37 of the Ohio Administrative Code. The Commission also asked all interested parties to file comments on the proposed rule changes by September 16, 2011 and file reply comments by October 6, 2011. On September 16th, comments were file by Columbus Southern Power Company and Ohio Power Company (collectively "AEP Ohio") and East Ohio Gas Company dba Dominion East Ohio. Citizen Power, Inc. respectfully submits these reply comments to the comments of AEP Ohio.

**COMMENTS**

In their September 16, 2011 comments, AEP Ohio recommends in several places that the definition of "Fuel source advisory council" be modified to indicate that it is an

advisory group comprised of public utility industry representatives.<sup>1</sup> Although Citizen Power agrees with AEP Ohio that public utility industry representatives are likely to have useful information related to current fuel supply, we do not agree that the Commission should be constrained in choosing the members of the fuel source advisory council to only public utility industry representatives. If the Commission believes that other individuals would give a helpful perspective, the Commission should be free to choose those individuals to serve.
